# **Annual Meeting**

Reyes provided an overview of the ITRC Annual Meeting schedule of events. Reyes shared the draft BOA Agenda for the Annual Meeting and walked through the topics currently on the agenda. The Board discussed the full Annual Meeting agenda and presentation of the team agenda and times. Reyes informed the Board that a Lifetime Achievement award winner was not selected for this year. The Secretary of California declined the invitation to speak at the Plenary session. The Plenary keynotes will focus on machine learning and artificial intelligence.

# 2025 Project Proposals – Schedule, Guidance, and Processes

Reyes shared the schedule for 2025 Project solicitations and an update about new materials and processes. The Board discussed the need for two team leaders and what language is needed to present that requirement in the proposal materials. Reyes discussed the purpose and value of the "Environmental Priorities" document for the proposal development process. The Board also discussed ways to engage the ITRC membership in building enthusiasm for submitting proposals starting at the Annual Meeting. ITRC will release an environmental topics list with the announcement for project proposals.

The Board discussed ranking criteria and processes for 2025 proposals. Reyes shared that ITRC will be transparent and provide a summary of the process for reviewing and ranking proposals on the ITRC website like previous years.
