ITRC Lifetime Achievement Award

Award Overview

ITRC's Lifetime Achievement Award is presented to an individual who has demonstrated exceptional dedication to ITRC's mission of advancing innovative environmental solutions. The awardee must have contributed significantly to both the mission of ITRC and the environmental field at large. The ITRC Lifetime Achievement Award recognizes contributions over the whole of a career; the purpose of the award is to recognize one individual who exhibits the criteria discussed below.

Evaluation Criteria

Lifetime Achievement Award Committee members will take the following criteria into consideration:

- Individual is a current or former ITRC member of demonstrated impact to the organization (i.e., served as a Team Leader, POC, Board Member, Trainer, Team Member).
- Individual has demonstrated efforts of inclusivity and innovation, reflected ITRC's core values and mission, and strengthened ITRC's relationships with external entities.
- Individual has cultivated an atmosphere of support and growth within the environmental field through mentorship of early-career professionals.
- Individual has provided outstanding contributions to the organization they represented, and the environmental field.
- Individual who is retired, or within one year of retirement, from full-time employment in the environmental field.

Nomination and Selection Process

The Lifetime Achievement Award Committee, made up of a diverse representation of ITRC board members, will review nominations and select the recipient.

- The nominations will be returned to the ITRC Director no later than January 13, 2023, for consolidation and submission to the Committee.
- All Nominees will be listed on the ITRC website.
- Committee members will screen the complete list of nominations and select the awardee no later than January 27, 2023.
- The awardee will be notified immediately after selection and invited to attend ITRC's Spring Meeting, where the recipient will be honored with a short presentation of their accomplishments.
